

Section II: Process Description

Associated Documentation

This unit process is composed of this document and the data sheet (DS) *DS_RMA_NaturalGas_ConvOnshore_Marginal_2011.02.xls*, which provides additional details regarding relevant calculations, data quality, and references.

Goal and Scope

The scope of this unit process covers all aspects of raw material acquisition (RMA) and as seen in **Figure 1**. At the RMA downstream boundary, one kilogram of natural gas is delivered to the life cycle (LC) Stage #2 boundary for raw material transportation (RMT).

Boundary and Description

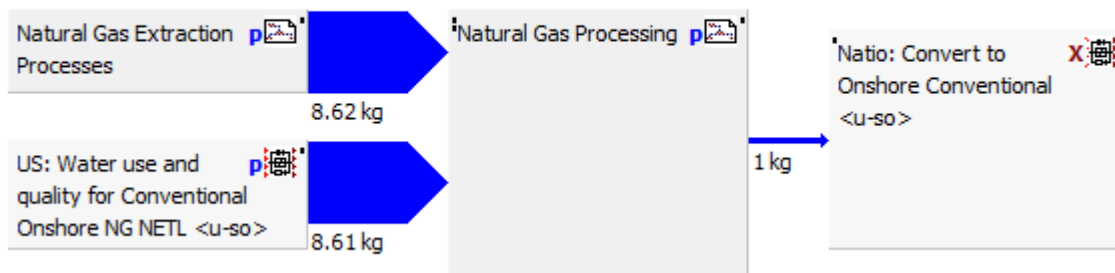
LC Stage #1, RMA of this unit process includes the acquisition of natural gas by conventional onshore extraction, represented by the marginal production of the next unit of conventional onshore natural gas. The natural gas is processed in preparation for RMT in LC Stage #2.

Construction of the wells and pipelines are included. The upstream profiles for concrete and steel are rolled up into this process.

An example plan is provided in **Figure 1**. Overall plans for extraction and processes were created.

The construction processes for both machinery and facilities were created. The machinery includes:
