Accordingly, the solicitation is hereby amended as follows:

The clause package attached to the SF-18 is deleted in its entirety and replaced with the attached clause package "SOL 89243320NAU000002 Clauses_RFQ_amend 0001." The following clause changes are included with this amendment:

1. Clause B.2, Distribution of Performance Incentive (Award) Fee, is revised to include the "Available Award Fee Pool" amounts established by the Government.
2. Clause H.21.D.1 and 2, Key Personnel/Program Manager, is revised to correct the penalty amounts for changes to the Program Manager or to a Key person other than the Program Manager. Changes are as follows:
 - D.1 is changed from \$500,000 to \$50,000
 - D.2 is changed from \$100,000 to \$20,000

Except as amended herein, all other terms and conditions remain unchanged.
