# RELEVANT PAST PERFORMANCE

The Offeror and all major or critical subcontractors shall describe their past performance in performing relevant work from the same contracts identified for relevant experience. The Offeror and all major or critical subcontractors bear the burden of demonstrating the relevancy of its past performance; therefore, the Offeror and all major or critical subcontractors shall provide the Past Performance Questionnaire and the Environment, Safety, Health, and Quality (ESH&Q) Past Performance Information Form provided in Section L, Exhibits D and F, for each contract or project cited, to the appropriate point of contact for that contract or project. The Offeror and all major or critical subcontractors should use the Past Performance Information Questionnaire Cover Letter provided in Section L, Exhibit C, to identify the contract or project for the reference to which the questionnaire is being sent. The point of contact for each contract or project should complete and submit the questionnaire directly to the Contracting Officer identified in the cover letter, prior to the closing date of the RFP.
